2025 Budget Discussion

NOTES-

In discussion with the auditors the following items were raised;

- Overall, there were no notable concerns with the 2023 audit. The year ended with a modest surplus.
- For the long-term the auditor pointed out the need to plan for major future costs in particular for the landfill closure, expansion or relocation which will be costly. (NOTE In the budget discussions held later in the meeting Council decided to start the targeted and regular saving of funds for the landfill during the estimated remaining 15 years before serious capital investment action would be needed).
- The auditor will send the landfill report prepared many years ago. (NOTE- the Colin Trivers report of 2002 has since been provided.)
- Tax Arrears mostly comprise properties in the process of Tax Registration with a few now at the Wishart Law firm in Sault Ste. Marie.

- Cancel all but one subscription of the Sentinel weekly paper. (Clerk's copy)
- Add totes to the old township records consolidation project for a total of \$1000

- If the projected deficit comes to pass then cover from Dock (Savings) Account
- Establish a Landfill Savings Account for eventual landfill closure, expansion or relocation. Deposit an initial \$10,000 in 2025 with a plan to add funds every year.
